



SMOKE ON THE PINEY BBQ COMPETITION COOKER APPLICATION

By signing on the reverse side of this document, you and all members of your team, herein known as the “Cooker”, agree to all terms outlined below:

- 1. ENTRY FEE:** \$75.00 per team (Before June 1st), \$100.00 per team (June 2-July 31)
*Each entry includes 4 wristbands for the festivities on Saturday.
- 2. RULES & SCHEDULE:** See the Official Rules and Schedule of Events flyer for details.
- 3. PAYMENT:** Checks should be made payable to “PRVFD” and mailed, along with this signed form, to PO BOX 33, Piney River, VA 22964.
- 4. CONTITIONS:** This Application applies to the “Cooker” listed on the reverse of this form and must be received by Smoke on the Piney (“SOTP”) no later than July 31, 2023.
- 5. CANCELLATION:** SOTP reserves the right to cancel any event if it is deemed necessary. In the event of such cancellation, SOTP will be rescheduled to a date we see fit. No refund will be given in the event the Cooker is unable to attend. SOTP and PRVFD will not be held responsible for any losses. Cooker may back out at any time, but no refunds will be given.
- 6. SET-UP/BREAKDOWN:** Cooker must adhere to SOTP guidelines to be completely staffed, set up and ready by 10:00am Saturday and must remain open until 5:00pm that day. Under no circumstances may a Cooker break down early.
- 7. INSURANCE:** Cooker acknowledges that SOTP does not maintain insurance covering the Cooker’s property. Such coverage would require the Cooker to obtain said coverage at their own expense.
- 8. CERTIFICATE OF INSURANCE:** A Certificate of Insurance must be presented to SOTP no later than September 1, 2023. Cooker will not be allowed to set up until this is received and approved. NOTE: for “hobby” Cookers, a Homeowner’s Insurance Dec page will suffice.
- 9. LIABILITY:** Cooker agrees to indemnify, defend and hold harmless SOTP, PRVFD and all affiliated associates and each of their officers, directors, employees, volunteers and agents from and against any actions, lawsuits, costs, damages, claims and expenses (including attorney’s fees) arising from any damage to property or bodily injury to Cooker, his agents, representatives, employees, or any other persons by reason of the Cooker’s occupancy or use of or participation in this SOTP event.
- 10. ENFORCEMENT:** Cooker agrees to comply with the regulations contained herein, and any rules and regulations set forth by the event site. SOTP reserves the right to evict Cooker in the event of any violation of these regulations. In addition, SOTP reserves the right to prohibit Cooker from displaying at all, or any part, of an exhibit that is deemed unsuitable for the event by the SOTP Committee.
- 11. SECURITY:** Overnight security will not be provided. SOTP will not be held responsible for any items left overnight by Cooker. You are responsible to close down and secure the times inside of their booth and/or reserved space. A security force will be present during the hours of the event for crowd control and general safety assurance.

12. **SALES TAX & PERMITS:** Cooker is required to collect all applicable State Sales Tax for any items sold (if applicable) and file a report with the Department of Revenue, and to obtain all necessary state and local permits for the operation of business including but not limited to those for vending.

13. **TENTS:** Cooker can only use tents with their own logo or tents with no logo. Use of tents with another business name or logo who are not sponsors of the event will not be permitted for use at any time and will be required to be removed immediately.

14. **GENERATORS:** Generators are not allowed to be used on site.

15. **OUR AUTHORITY:** SOTP reserves the right to amend these regulations at any time as it deems necessary and without notice. SOTP shall have the full power to interpret and enforce all the regulations contained herein.
